The Public Hearing was called to order at 7:00 P.M. by Supervisor Napoli and the following legal notice was explained by Supervisor Napoli:

ORLEANS CALLING SUPPLEMENTAL
PUBLIC HEARING TO BE HELD ON JULY 18, 2016
WHEREAS, the Town Board of the Town of Ridgeway (herein called "Town Board" and "Town", respectively), in the County of Orleans, New York, has, pursuant to Town Law, created the Town of Ridgeway Water District No. 13 (the "District"); and

created the Town of Ridgeway water District, No. 13 (the "District"); and
WHEREAS, in connection with establishment of the District, the Town Board directed Chatfield Engineers, P.C., competent engineers licensed in New York, to prepare a map, plan and report for certain capital construction improvements within the District (collectively, the "Project"); and
WHEREAS, the Town Board took the following specific actions with reserver to the Project: (a) adopted on January 21.

tions with respect to the Project: (a) adopted on January 21 2014 a certain order calling for a public hearing, (b) on Feb ruary 18, 2014 held such public hearing, (c) on February 18, 2014 adopted a certain resolution establishing the District and (d) on February 18, 2014 adopted a bond resolution;

where As, the plan of financing for the Project identified an estimated maximum cost of \$800,000, with the issuance of estimated maximum cost of to exceed \$800,000, and WHEREAS, due to construction bids coming in higher than anticipate, the estimated maximum cost of the Project has increased from \$800,000 to \$900,000; and

WHEREAS, the Town has secured additional grant funding from the United States Department of Agriculture - Rural Development Agency ("Rural Development") to cover such increased costs for the Project; and

WHEREAS, the total amount of grant funds from Rural De velopment has increased from approximately \$410,000 to \$556,000 since the original proceedings were originally unWHEREAS, the scope of the Project is substantially the same as originally presented and identified in such originally plan and report; and

WHEREAS, the Town wishes to proceed with the Project at a revised estimated maximum cost of \$900,000, and

WHEREAS, the Town has kept the amount of bonds author-ized the same as identified in the earlier proceedings since Rural Development is providing grant funds to cover such

additional costs; and WHEREAS, the Town Board has determined that they want to hold a supplemental public hearing to advise members of the District of the proposed increase in total cost of the Proect: and

WHEREAS, all other terms, conditions and estimated costs as set forth in the earlier proceedings, will remain substan tially the same or be less than such amounts identified in such earlier proceedings.

NOW, THEREFORE, BE IT

ORDERED that a meeting of the Town Board of the Town of Ridgeway will be held at the Town Hall, 410 West Avenue, Medina, New York on July 18, 2016 at 7:00 o'clock PM (prevailing time) or shortly thereafter for the purpose of con-ducting a supplemental public hearing regarding the in-crease in the cost of the District and to hear all persons increase in the cost of the District and to hear an persons in-terested in the subject thereof concerning the same and for such other action on the part of the Town Board with rela-tion thereto as may be required by law, and be it FURTHER ORDERED, that the Town Clerk publish at least

once in each newspaper designated as the official newspa per of the Town for such publication, and post on the sign board of the Town maintained pursuant to subdivision 6 of Section 30 of the Town Law, a copy of this Order, certified by said Town Clerk, the first publication thereof and said posting to be not less than ten nor more than 20 days before the date of such public hearing.
