The Public Hearing was called to order at 7:00 P.M. by Supervisor Napoli and the following legal notice was explained:

Local Law #2 of the Town of Ridgeway of 2014 A Local Law to Amend the Town of Ridgeway's Zoning Ordinance.

Section 107 of the Town of Ridgeway Zoning Ordinance thereto shall be amended as stated as follows:

## SECTION 107 - VIOLATIONS AND PENALTIES

Any person, firm, corporation orother business entity who violates, disobeys, neglects or refuses to comply with any provision of this Local Law Ordinance shall be subject to a fine of a minimum of one hundred dollars (\$100.00) and not exceeding three hundred and fifty dollars (\$350.00) or imprisonment for a period not to exceed six (6) months or both for conviction of a a first offense; for a conviction of a second offense voth of which are committed within a period of five years, punishable by a fine not less than three hundred

fifty dollars (\$350.00) nor more than seven hundred dollars (\$700.00) or imprisonment for a period not to exceed six (6) months or both; for a third or subsequent offense all of which are committed within a period of five years, punishable by a fine not less than seven hundred dollars (\$700.00) nor more than one thousand dollars (\$1000.00) or imprisonment for a period not to exceed six (6) months, or both. Each week's continued violation shall constitute a separate additional violation and offense.

All other provisions of the Town of Ridgeway Zoning Ordinance shall remain unchanged. This local law shall take effect upon proper passage and filing of same.

As there was no further discussion on the Local Law#2 of 2014 entitled a Local Law to Amend the Town of Ridgeway's Zoning Ordinance, the public hearing was closed at 7:05 P.M.
