Highway: Mark stated that the Highway guys had paved Bates road, and had chip sealed 4 miles on Mill road. Mark further stated that the canal approaches and guardrail maintenance was now back under the State of New York. The Niagara County water department was out and assisted with rebuilding the Altitude Valve. Mowing and reading water meters were being done. Mark said that he had some questions about the reserve funds account and asked Brian to please speak with Lynn Johnson to get an answer to his questions and and get back with him.

**Towns Attorney**: Kathy explained the BAN renewal for water district #7 that we had done a short term BAN in hope of getting the Principle and Interest in a long term renewal with water district #7 in September.

## Councilman Reports:

Councilwoman Fisher: Sarah stated that she had attended the Fire Departments monthly meeting. The new sign was up and working at the Fire Hall and the old sign had been taken to the Knowlesville Department. The fireman had attended HIPPA training and that Valerie Bush has resigned from the training position.

Councilman Toussaint: Met with the summer recreation program director. The staff is in place and the sign-up for swimming has started. Jeff asked that we revisit the budget to increase the summer recreation funding for next year to cover the rising minimum wage.

**Councilwoman Woodruff:** Mary stated that the United Way has cut some of their funding for the summer recreation program, but was unsure at this time as to why it had been cut. Mary further stated that the hiring for the General clerk position has begun and that the cut off for application would be June 20<sup>th</sup> as posted in all the ads and then that the interview process would begin.

Councilman Stalker: Dave spoke to Mark Goheen regarding Bates road Cemetery and told him that he had been by and that it looked good and like that the vault approach had been blacktopped making it look much better.
