Highway Superintendent: Stated that the lift bridge was closed. The Highway guys will be changing out a pipe on Marshall Road after the lift bridge re-opens. Highway will be going to Clarendon for some shared service work then next to Carlton. Mark is hoping that the State Highway Department will help out with some black top. Several cross pipes to replace. Highway will be black topping Horan Road. Mark stated that it cost \$11,000.00 to repair the Mac Truck.

Code Enforcer: Dan stated that he is working on the Stronelli case (Horan Road). Dan further stated that he will be meeting with Richard Thaine and William Wells in regards to their violations. The Planning Board is working on a cell tower permit for Horan road and a home distillery permit, also very busy with building permits.

County Legislator Report: Lynne Johnson stated that the usual 2% tax cap which last year was actually 1.28% is truly 2% this year. The County does not normally override the Town has in the past if the County does it takes 2/3 of the legislators to override it.
