Supervisor Napoli stated that Interim Highway Superintendent John Olinger was given the go ahead to begin the hiring process for the 4th highway position with the assistance of Councilwoman Woodruff and Councilman Toussaint who preside over the personnel committee. At this point and audience member asked how to apply for the position and Supervisor Napoli stated that it would be in the paper.

DEPARTMENT AND LEGISLATOR REPORTS

TOWN CLERK: Working non-stop to try and organize the Bates Road Cemetery Filling system with Deputy Kilburn, as well as working closely with interim Highway Superintendent Olinger. Kaiser further stated that the interim Highway Superintendent and she have been working hand in hand on a sustainable system. Further stating that she Highly Suggest No new graves be sold on the West Side of the Cemetery, while still honoring deed holders for the West side. The records are just to conflicting to move forward on that side in good consciousness.

Kaiser also stated that Councilwoman Woodruff and she had done Deputy Kilburn's 90 day evaluation and that Laurie passed with flying colors and is a great addition to the staff.

ASSESSOR: ABSENT

CODE ENFORCEMENT: Working on closing out building permits, as well as site plan review for craft shop on the Ridge, porch and handicap ramp. Wolfe also stated that he will be writing weekly tickets for two properties that are out of compliance and have been for a long time and there will be an appearance ticket for October.

HIGHWAY SUPERINTENDENT: Milling and paving Bates, Beals and Telegraph road, also working with LaBella regarding the possibility of increasing are water supply that comes from Albion in an attempt to save money and increase the water pressure in Knowlesville and surrounding areas. Olinger further stated that the Town Had received the check for \$50,000 from the DASNY for the STAMP Grant.

TOWN ATTORNEY: Nothing further at this time.

LEGISLATOR: Lynn Johnson stated that she signed the State of Emergency for Lake Ontario lakeshore damage. Johnson stated that the State of New York will be awarding \$300,000,000, \$20 million will be paid out in individual claims with \$15, 000,000 slated for Orleans County in 2019 and Johnson will continue to keep Orleans County in a State of Emergency until funding is issued and Lake Ontario is currently 11" over flood stage.

COUNCILWOMAN FISHER: Fire Company will have its new pumper by 12/29/2019 April Fearby the new President stated that the Fire Company has received many new hall rental requests and last year they grossed over \$9626.01 in revenue from banquets after expenses were paid.

COUNCILMAN TOUSSAINT: The Summer Recreation program is concluded for the 2019 summer season. There has been no closing meeting as of yet. The program is on track to hopefully include the swimming portion next year and the repairs have been made to the pool.

It was at this point when members from the audience, Dave Parsell Jr., Christina Parsell, Bethany and Chis Clark from Knowlesville stated that they were having serious problems with the occupants of a house #3634 Knowlesville road. The Residence stated that they were asked to reach out at a Town Board meeting by the State Police officer that was last called out by the residents.

The residents stated that there are several parties approximately 8 separate, some registered sex offenders living in the house that is currently zoned as a single family residence. The residents further stated that the police have been called out several times, that there have been fire arms discharged from the house, they have witnessed drug deals, there are dogs running loose, there are people speeding up and down the road and they are very concerned for the small children in the area as well as the safety of their homes.

The residents asked if a "Child at Play" sign could be posted.

The residents were given several contacts to speak with only to say that they have tried everything. It was at this point that the Town board as well as the Town's attorney offered several suggestions and Supervisor Napoli stated that he would reach out on their behalf and Code enforcement Officer Wolfe stated that he would do whatever he could but that the owner lives in Monroe County, the residents stated that there is a new owner, Mr. Wolfe stated that he would look into it.

Town Attorney Kathy Bogan told them to make sure that they document everything keeping a record of all infractions as well as official response with times and dates.

The residents thanked the Town Board and stated that they hoped that they could help as they were desperate to bring this to an end.
