**Councilwoman Fisher**- the Councilwoman stated that she had attended the Fire Company meeting at which time the Fire Company observed a moment of silence on September 11, 2019 in remembrance of all lives lost on that day.

The truck committee stated that the pumper is currently in production. The Fire Department will be looking into a grant for a new exhaust system for the fire hall. A sentimental gentleman is doing a memorial quilt for first responders and the fire department donated 3 of their patches to be used in the quilt.

September 17-24,2019car take down maneuvers at the fire hall parking lot cones are being set up. Ridgeway Fire Department will once again be storing the Safety Trailer for the County. The meeting adjourned at 8:06P.M.

He also asked how much the Fire Company paid for the new truck and Councilwoman Fisher stated approximately, \$300,000.00. Mr. Toale asked what the Fire Company did with the old pumper and was told that The Town of Ridgeway Highway Department purchased it for \$10,000.00, the fire company did not have to bid the sale of the truck out as they are a private company.

As there were no further questions Supervisor Napoli asked for a motion to adjourn Councilman Stalker made the motion, seconded by Councilwoman Fisher and the meeting was adjourned at 7:27 P.M.
