NOW THEREFORE, BE IT RESOLVED BY THE TOWN BOARD AS FOLLOWS:

For the sole purpose of qualifying the interest payable on the Note for exclusion from gross income pursuant to the provisions of Section 150(e) of the Code, the Town Board hereby approves the issuance of the Note by the Ridgeway Fire Department in a principal amount estimated not to exceed One Hundred Ninety Two Thousand Six Hundred Thirty Two Dollars and Ninety Cents (192,632.90) Dollars, provided that the Note shall be an obligation of the Ridgeway Fire Department and not of the Town.

THE NOTE SHALL NOT BE A DEBT OF THE STATE OF NEW YORK OR THE TOWN OF RIDGEWAY, NEW YORK, AND NEITHER THE STATE OF NEW YORK NOR THE TOWN OF RIDGEWAY, NEW YORK, SHALL BE LIABLE THEREON.

This Resolution shall take effect immediately.
