that the porch was already there and they weren't encroaching the road but extending the length of the property. There were no concerns from the board members. Public Hearing was opened at 7:16pm-A Variance Application for Darrel Smith 2735 Oak Orchard River Rd., for a 35' front setback and 15' rear setback to replace a garage. There were two neighbors were present. The board asked the neighbor what the consensus was in the neighborhood. The neighbor stated that they felt it was a good thing. He also stated that the property line is on the creek and there is a steep bank that nothing could be built on even if they wanted to. The applicant arrived and the board asked what size his current garage was and what the measurements of the replacement garage were. He stated he was increasing by 10 feet and the new dimensions would be 40' x 32'. The board members had no concerns. Chairman Meyer closed the public hearing at 7:22 pm. A motion was made to approve the variance application as submitted by Richard Cichocki with a second by Dan Wilson. All were in favor and the motion carried.

At this time, Chairman Meyer asked the board if there were any further questions or concerns. Since there were none, he asked for a motion to adjourn the meeting. Richard Cichocki made a motion and was seconded by Dan Wilson. The motion was carried and the meeting was adjourned at 7:25 pm.
