#### **Department Reports:**

**Town Clerk Kaiser:** Town Clerk Kaiser reported that she was finished with the 2021 tax collection and that penalties in excess of \$8,000. were paid to the Town Supervisor. Revenue was higher due to the ability to take partial payments.

Kaiser further stated that she had worked at the Vaccination Clinic at the Ridgeway Firehall on Monday May 10,2021 and was impressed with how organized it was.

**Town Assessor Laszewski**: Assessor Laszewski stated that the change of assessment notices had gone out. Councilman Woodruff asked when assessments based on recent sales at much higher prices would take effect? Assessor Laszewski stated only in an update year.

Laszewski further stated that Grievance Day would be Tuesday May 25<sup>th</sup> from 4 P.M. until 8 P.M.

**Town Attorney Bogan**: Ms. Bogan stated that at the Association of Municipalities meeting District Attorney Cardone and Sherriff Bourke would be there to discuss the possible problems they see from law enforcement side from the legalization of Marijuana and the pros and cons of opting in or out.

Bogan further stated that the County's proposal for broad ban would address the low speed or no speed in Orleans County for the underserved or unserved customers.

**Code Enforcement Wolfe**: Wolfe stated that Building Permits were picking up. Wolfe further stated that it was deemed the Code Enforcement officers responsibility to attain their 24 hours of continuing education. Since there is no in person training, all training is being done through webinars. He is doing his best to take as many as possible and he would do his best to get there but that it will most likely take all year. Wolfe further stated that one of the on-line training sessions was cancelled. Wolfe further stated that he would look into the West Center Street Ext. complaint and report back to the Board.

**Legislator Johnson**- Legislator Johnson stated that the County had received a R.F.P (request for proposal) from a broad ban vendor going out at the end of the month. Johnson further stated that she has seen that Spectrum is out finally fulfilling requirements now that they have competition. It is a good thing for everyone that they finally have some competition. Johnson further stated that this is all happening because of Supervisor Napoli getting the ball rolling 12 years ago trying to get other vendors for broad ban for everyone.

Highway Superintendent Olinger: Olinger stated that Joelle Brown was almost finished with the required water quality report. The Highway had been working on mowing cemeteries as well as finishing the ditching project on Portage road that had turned into a much more involved process, but that it will look much better when it is completed. The new 10-wheeler showed up and Olinger is currently speaking with the Town of Yates about the possibility of purchasing the old roller. Olinger further stated that there might be a possible Water Quality Grant and the Town would only have to pay half of the cost in building a new salt shed. Olinger stated that the highway men were also doing road work and paving.

Soil and water got a new hydro seeder and may do some seeding for the Town at no charge.

Councilman Payne: Nothing at this time.

**Councilman Toussaint**: Councilman Toussaint stated that he would be meeting Tuesday morning regarding the Summer Recreation Program. Toussaint further stated that there would be a summer recreation program. There will be a swim program and Lyndonville will be invited to participate. Toussaint stated that he was very happy that the Town was able to do this and that he felt it was a good way to give back to the Community.

**Councilman Woodruff**: Councilman Woodruff stated that it was great to see things moving back to some normalcy and that there would be a Children's Summer Program. Woodruff further stated that the new Home Town Hero's banners would be going up on Main Street and West Ave. in Medina. The Councilman further stated that she had already been approached regarding 2022 banners.

Councilman Stalker: Councilman Stalker stated that he had nothing to add at this time.

As there were no further questions or concerns the Supervisor asked for a motion to pay the bills as presented.
