The solar company is having trouble getting the spruce trees in and are currently back ordered. Dan will call for another update. Special Use Permit- Medina Solar Project. Two sites- 11074 and 11202 Ridge Road. MRB and C&S still working out the special conditions so that the building permits can be issued. The town has received the PILOT plans for both sites.

### **NEW BUSINESS:**

Site Plan Review for Living Waters America, LLC-3161 Fruit Ave- proposed 11,200 sq ft 80' x 140' warehouse addition to back of the existing building. They are expanding their business to be wholesale distributers. Items are trucked in, repackaged and shipped back out. Dan showed the board members the site plans.
