#### **DEPARTMENT AND LEGISLATOR REPORTS**

TOWN CLERK: Deputy Clerk, Laurie Kilburn, stated that the Clerk's office is still receiving water bill payments on a regular basis. Preparing for hunting license sales which begins on August 2<sup>nd</sup> and marriage license sales have increased as well.

ASSESSOR: Assessor Laszewski stated that Assessor Assistant, Julie Cechinni, has registered for her final two classes. Going out and getting pictures of completed building permit projects for assessment review.

CODE ENFORCEMENT: Code Officer Wolfe stated that property violations on Culvert Road were issued tickets. Will need to send a few lawns out for bid to be cut. Finishing some building permits. Code Officer Wolfe, read his letter of resignation from the Town of Ridgeway and Yates to be effective 12/31/2021. He will continue working a few days for the Town of Shelby. A resolution was made and accepted with regret by the Town.

HIGHWAY SUPERINTENDENT: Highway Superintendent Olinger stated that roadwork is halfway done, depending on Marshall Road. Mowing ditches, flushing dead ends and water samples are coming in. Had a couple water leaks over the past few weeks and wanted to thank Town of Yates, Carlton, Village of Medina, Lyndonville and Albion for their assistance. Paving done on Dresser Road. Portage, between Bates and Culvert needs to be paved. Will level it for winter. East Scott Road also needs paving.

TOWN ATTORNEY: Attorney Bogan stated that she completed the legal notice for the public hearing in August regarding opting out of the Marijuana Sales and Consumption, Local Law #2. Given to Clerk to put in Batavia Daily News. Garden out front looks nice and makes the Town look wonderful.
