B. Department and County Legislator Report

Town Clerk: Clerk Hill said that less than 250 parcels out of over 3000 have yet to pay their taxes. Water bills have been keeping the office busy.

Code Enforcement Officer: CEO Raduns explained to the Board that he has completed 125 out of 150 hours and has an exam coming up. He is learning the ropes, going out on calls and inspections as well as organizing paperwork in the Code office.

Councilman Toussaint: The Summer Rec program had a meeting last week and the budget for this year is tight due to rising minimum wages. While matching staff/hours with the number of kids participating, they still have quite a gap in what is needed to cover it all,

especially the swim program that cannot cut back in supervision. He told the Board that he would like to see the Town contribute \$7,000 as the Town of Shelby does.
