OLD BUSINESS:

WD#15: Reconfigure district: Supervisor Napoli and Highway Superintendent Olinger had a meeting with MRB group about Water District 15. They were told that even with reconfiguration, the USDA would not fund the project and the debt service for each household would be extremely high. They are looking at other options.

NEW BUSINESS:

RESOLUTION NO. 72 - 8/15/2022 RESOLUTION: ARPA AWARD TO RIDGEWAY VOLUNTEER FIRE COMPANY: \$60,000

Offered by Councilman Barber who moved its adoption. Seconded by Councilman Payne.

Adopted: 5 Ayes 0 Nays

Resolved to award ARPA funds to the Ridgeway Fire Company in the amount of \$60,000.

Ridgeway Fire Co. President Don Marchner thanked the Board on behalf of the Fire Department. He explained that it would help greatly to cover the loss of revenue over last few years and will help buy equipment and gear that is needed. Mr. Marchner said that in the long run, this benefits the entire Town of Ridgeway and that the money will be put to good use.

RESOLUTION NO. 73 - 8/15/2022 RESOLUTION: DECLARE AS JUNK LIST PROVIDED BY TOWN CLERK AND DISPOSE OF ITEMS

New Building Permit Application: Code Enforcement Officer Raduns explained that he has changed and simplified the building permit application, making it less redundant and easier to fill out. The application would be used for the Towns of Ridgeway, Yates, and the Village of Lyndonville. The Board had questions about any differences between the old and new application, and asked to see both applications before making a decision. It was also brought up that it may be a good time to update the fee schedule. The matter was tabled.

B. Department and County Legislator Reports:

Town Clerk: Clerk Hill said that August 1st began a new year for hunting licenses, and her office has been busy selling those as well as cleaning up Bates Road Cemetery maps with the help of Superintendent Olinger. The Clerk's office also sent out letters to dog owners whose licenses expired in 2020 in an effort to get all dog licenses current.

Assessor: Assessor Laszewski updated the Board about a new bill that was recently signed into law that allows for higher exemption thresholds.

Code Enforcement Officer: CEO Raduns said he has been doing permits, inspections, organizing, and training. He told the Board that the Town of Yates is using ARPA money to put all codes, local laws, and zoning ordinances online, and he would like Ridgeway to look into doing that as well. The cost would be around \$15,000.

Highway Superintendent: Superintendent Olinger said the highway department will be working on weed control, and fall mowing is coming up soon. The department has helped other towns in the area with paving and has been flushing water lines, painting fire hydrants, and installing culvert pipes.

Town Attorney: Attorney Bogan wanted to personally thank the Ridgeway Fire Department for their quick and impressive response to a bad accident near her home recently.
