B. Department and County Legislator Reports:

Town Clerk: Town Clerk Hill said her office has been organizing and going through old storage boxes, getting rid of things that have passed their retention dates. Hunting sales have started for the new season.

Code Enforcement Officer: CEO Raduns said he has issued two building permits, closed out eight permits, and had a couple of complaints. He has also been working on 1203 inspections, researching special use permit procedures and firework permits. He told the Board that the Planning Board had met with those working on the three new solar farms.

Town Attorney: Attorney Bogan reminded the Board that the Orleans County tax foreclosure sale was tomorrow (August 22) at the Elks Lodge. She said there were three or four properties in Ridgeway, including one that CEO Raduns had recently condemned. CEO Raduns explained that the basement had a few feet of standing water and many other safety issues. She explained that new regulations prevent the County from keeping any surplus funds per unit so she did not expect the County to recoup a lot of back taxes.

Highway Superintendent: Superintendent Olinger said the highway department has been working on ditching projects, keeping up with roadside and cemetery mowing, flushing dead ends, and finishing up road work.

NOTICE: Site Review and Data Collection in Your Area

Please be aware that the NYS Canal Corporation, through its engineering consultant Schnabel Engineering, will perform site reviews and data collections that will include visual inspection of embankments and measurements of various structures on the embankment or in the vicinity of the Canal. The site reviews and data collection will take place over 80 miles along selected Canal embankments in your area and will include the following Towns during early August through September:

Area 1— Macedon, Perinton, Victor
Area 2— Pittsford, Perinton, Penfield, Brighton, East Rochester
(Irondequoit Creek)

Area 3 – Greece, Ogden, Gates, Parma, Rochester (Round Pond Creek, Northrup Creek)

Area 4 – Parma, Ogden, Clarkson, Sweden, Greece
Area 5 – Murray, Hamlin, Kendall, Gaines Albion, Clarkson (Sandy Creek)
Area 6 – Ridgeway, Carlton, Gaines, Albion (Oak Orchard and Otter Creeks)
Area 7 – Hartland, Yates, Royalton, Carlton, Ridgeway (Jeddo and Johnson Creeks)
Area 8 – Lockport, Royalton, Newfane, Hartland (Eighteenmile Creek)

You may notice crew members, wearing hard hats and high-visibility vests. It will involve several technicians using measurement equipment, like tripods and levels, in areas adjacent to and down gradient of the Canal and should not impede Erie Canalway Trail access.

PLEASE NOTE THAT THIS ROUTINE SURVEY WORK IS NOT A PART OF THE EARTHEN EMBANKMENT INTEGRITY PROGRAM. Minimal, small vegetation may be removed to aid in our inspection work.
