#### B. Department and County Legislator Reports:

**Town Clerk**: Town Clerk Hill said she was at a NYSTCA training this morning and has been working on making sure everything is in order before our audit. She received a quote for a color printer to replace the smaller color printers around the office; she will find out how much we spent on color toner over the past year to see if it is worth the added monthly cost. Town Clerk Hill is also looking into costs and options for a dog enumeration as one has not been done in many years.

**Code Enforcement Officer:** CEO Raduns said he has issued five building permits for August, sent out five violation letters, primarily for junk, and had one court appearance. He said he is spending more time in the office as requested to be available for walk ins.

**Assessor:** Assessor Cecchini said she is sill getting many questions and walk-ins regarding the STAR program and STAR checks. Houses are still selling above assessed value.

**Highway Superintendent:** Superintendent Olinger said the materials for the waterline extension are for Knowlesville Eagle Harbor Road. His department will work on that project during a mild winter.

**Attorney:** Attorney Bogan said she is still working on the unsafe structure law. She has been in contact with Light Edison Strategic Accounts who would like to see their solar project on Ridge Road closed out. She will work with them and Jason to at least get a conditional permit, as planting barrier trees may not be done until spring. She also told the board that the District Attorney can be used for code enforcement court matters.

**Village of Medina:** Village Trustee Marciano said the Village has a couple of 5ks coming up as well as Ale in Autumn.
